WE ARE THE ONLY PROGRAM IN CROOK, DESCHUTES AND JEFFERSON COUNTIES PROVIDING THERAPEUTIC CLASSROOMS, PARENTING EDUCATION SERVICES, AND FAMILY SUPPORT TARGETING YOUNG CHILDREN AT SIGNIFICANT RISK FOR ABUSE AND NEGLECT.
